To facilitate the timely and orderly receipt, processing, and tracking of Information Requests (Information Requests are subpoenas, court orders, etc., as defined in our Guidelines) seeking customer-related information concerning telephone numbers, **a completed cover page must be submitted in addition to each Information Request.**

****INSTRUCTIONS:** Please observe the following for use of this form, which is required for the submission via legal@inteliquent.com

1. **DOWNLOAD** the cover page form. The form **cannot** be completed online (data is not saved for transmission).
2. **COMPLETE** by typing into all fillable fields. A digital copy is required; do not handwrite.
3. **SAVE** the completed form as a digital file (do **NOT** scan it or consolidate).
4. **ATTACH** the saved form to the submitting email as a file **separate** from the Information Request.
