This tariff contains the descriptions, regulations, and schedule of rates and charges applicable to the furnishing of resold and facilities-based residential and business service for Telecommunications Services furnished by Broadvox-CLEC, LLC(Company). The Company will mirror the exchange area boundaries as stated in the tariffs of Verizon Pennsylvania LLC Pa. P.U.C. No. 180A, 182, 182A, 185B and 185C, Verizon North LLC Pa. P.U.C. Nos. 1, 3, 5 and 6, The United Telephone Company of Pennsylvania LLC d/b/a CenturyLink PA P.U.C. No. 27 and Windstream Pennsylvania LLC - PA P.U.C. Tariff No. 7. Some rate groups are listed in Section 9 of this tariff. Local exchange calling areas and rate groups are listed in Section 10 of this tariff.

6.7 Business PBX Trunk Service
